- 1. Please fill in all the details in CAPITAL letters.
- 2. Please note that you am mandatorily required to register if you:
 - (i) had turnover of mom than Rupees 5 lakhs in the preceding financial year, or
 - (ii) exceed turnover of Rupees 5 lakh, in the current year; m,
 - (iii) am liable to pay in,, or am registered or required to be registered under Central Sales Tax Act, 1956
- 3. Phase note that irrespective of the quantum of turnover of the business, a dealer may apply for voluntary registration under the Delhi Value Added Tax Act, 2004.
- 4. For field 3, an "importer" means
 - (i) a person who brings his own goods into Delhi; or
